IMPORTANT INFORMATION REGARDING ENTRY FEES

The Coonawarra Dragway now employs a “user pays” system for competitor and crew entry, which is outlined as follows.

You will be required to complete and send in your entry form with your fees, by Australia Post prior to the cut off date. Entries will be accepted on the day but the late fee will be added.

On the day of competition all competitors and crew of 16 years and older will be required to pay the gate fee before entering the facility. (The Cheque or Money order that accompanied your entry form only covers the competitors race fees.)

You will then proceed into the pit area where all secondary vehicles and open trailers will be required to go into the Paddock directly opposite the pit area.

The competitor and the three listed crew will then proceed to the Office for credentials check in.

You will then be required to present the vehicle with your completed competitor declaration form to the auditors for vehicle compliance checking.

Only then will you be able to qualify and compete. Crew with the correct armbands will only be permitted onto the racing surface when accompanied by the race vehicle.

No refunds will be issued on the day, however any refund requests may be logged at the office.

BURNOUT COMPETITION

ALL BURNOUT COMPETITORS MUST ARRIVE BY 3 PM.

- 1) All competitors will be required to hold a DDL as a minimum. You must have the relevant licence and safety requirements suited to your vehicle, as per ANDRA regulations.
- 2) Long sleeve shirt / long trousers / open faced helmet / full shoes (non flammable) as a minimum
- 3) No consumption of alcohol will be permitted in the 12 hours prior to and including at the event.
- 4) All vehicles must be presented for scrutineering, with relevant licence and safety requirements upon arrival.
- 5) If your vehicle is not able to pass the scrutineering process you will not be permitted to compete. If you are unfamiliar with what is required, please contact us.
- 6) Treaded tyres must be used, retreaded tyres not permitted.
- 7) Competitors doing static burnouts, going off onto the dirt or touching the barriers will be disqualified immediately.
- 8) Competitors on completion of their burnout must exit the track via return road.
- 9) We will not tolerate any deliberate unsafe behaviour that could injure spectators or damage the racing surface, please consider this when competing. If it is deemed necessary to disqualify you we will not hesitate to do so.

A reminder that persons under the age of 18 years are not permitted into restricted areas (unless a minor consent form has been completed by a parent or legal guardian and the minor is over 14 years of age).

All competitors must show proof that they have held a civil drivers licence, P plate and above on the day of competing.
